



**Announcement by Chiang Mai Primary Educational Service Area Office 5
on Goodwill in Administration of Chiang Mai Primary Educational Service Area Office 5**

Thai government, by General Prayut Chan-o-cha, has promoted good governance in governmental administration and prevention and suppression of corruption and misconduct in the public sector, which has been declared to the National Legislative Assembly of Thailand on 12th September 2016. At the same time, there are also the Code of Ethics for Civil Servants B.E. 2552 (A.D. 2009), the National Strategic Plan on Anti-Corruption, Phase 3 (2017 – 2021), Announcement by Office of Basic Education Commission on Code of Conducts for State Officials of Office of Basic Education Commission B.E. 2552 (A.D. 2009) dated 31st August 2009, Manual for Integrity and Transparency Assessment (ITA) of the Office of the National Counter Corruption Commission (NACC) and the Office of Public Sector Anti-Corruption Commission (PACC).

Chiang Mai Primary Educational Service Area Office 5 has studied and made an action plan to prevent and suppress corruption Chiang Mai Primary Educational Service Area Office 5 for the period of 2016 – 2019 (4 years). The plan covers transparency, accountability, freedom from corruption in the operation, organizational culture, work morals and internal communication, and is based on the belief that all state officials and personnel of the organization will have behaviors that respond to the needs of the society and are trusted by people. There is also expectation that all state officials must act honorably when working in accordance with their responsibilities and adjust their own conducts to be appropriate all the time.

I, as one of the governors of Chiang Mai Primary Educational Service Area Office 5, would like to express the goodwill to be prompted to support all state officials and personnel of the office to work with ethicality, transparency, efficiency and effectiveness in order to preserve the benefits of the state and to deliver justice to all stakeholders in the fair and equivalent manner.

I will perform the administrative tasks to prevent and suppress corruption in the public sector with the awareness and appreciation to the responsibilities that I have; and will work with the fullest extent of intelligence, capabilities, integrity, honesty and prudence, with the awareness of wrong doings, and things to do and to refrain from, in order to prevent damage or jeopardy to the work and to ensure the highest possible benefits, with the adherence to the principles of good governance and the commitment to anti-corruption work and doing good deeds for His Majesty the King, and will be committed to making the Chiang Mai Primary Educational Service Area Office 5 become a white governmental organization in the sustainable manner through the following actions:

1. To do work in all steps in accordance with laws, regulations and restrictions in the strict, thorough and complete manner; and to encourage all personnel to work with adherence to laws, regulations and restrictions;

2. To implant and promote the anti-corruption recognition and value and the idea to separate self-benefits from collective ones in order to build the conscious in moral and to prevent corruption in the organization, and to emphasize on internal balance of power that is strong and efficiency, which will enable personnel of Chiang Mai Primary Educational Service Area Office 5 to be aware of bad effects from corruption to the public sector and the entire country, in order to create the anti-corruption culture;

3. To accept no act of corruption and to tolerate no corruption of any type;

4. To build the conscious of students of schools undertaken the Office of Basic Education Commission in order to create the awareness of and the resistance to corruption;

5. To emphasize on the administration that leads to the accomplishment of the mission of the office of the education area with good governance and

6. To follow the following guidelines for operations and collaborative activities:

- 6.1. To coordinate and collaborate in the operations to drive the National Strategic Plan on Anti-Corruption, Phase 3 (2017 – 2021);

- 6.2. To coordinate and collaborate by joining the anti-corruption network with Office of Basic Education Commission, education offices of the area and schools under the education offices of the area;

6.3. To educate administrators and personnel of all schools of the guidelines to promote ethics and morals in order that they will participate in the monitoring and inspection to resist all types of corruption;

6.4. To provide consultancy, suggest guidelines and monitor and evaluate anti-corruption operations; and

6.5. To collaborate in any other anti-corruption activity in all forms with all other agencies with full capacity.
